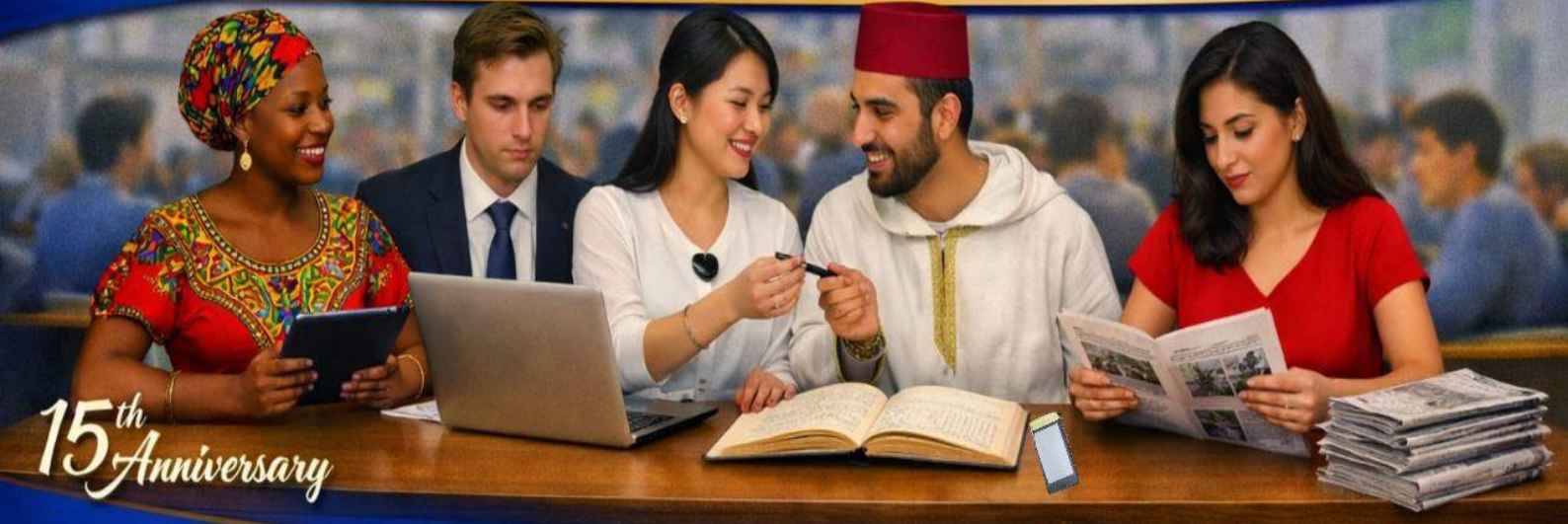

## Concept Note

### Preamble

#### **Media and Information Literacy Diplomacy as a Response to regression of linguistic rights, cultural rights, media and information rights and digital rights in an era of uncertainty and global erosion of trust**

At a time of shrinking of human rights, surge of disinformation, regression of the freedom of the press, freedom of expression and academic freedom, and the worrying tendency to the homogenisation of cultures and languages by an increasing threat to diversity in its multifarious forms, mainly linguistic, cultural and media diversity, there is an urgent need to move into practical action and make Media and Information Literacy the vaccine to all these social, technological and political ills, making of it a balancing power to build resilience and face up to all these challenges, by bridging education, diplomacy and technology as safeguards for human rights and democracy in digital spaces.

This global initiative, intertwining Media and Information Literacy (MIL) and Diplomacy to defend MIL as a fundamental human right to be accessible and empowering to all, lays focus in this first edition of the International Spring Academy on Media and Information Literacy Diplomacy (ISA-MILID) on the necessity to preserve linguistic diversity, cultural diversity and media diversity as basic human rights in the digital age, in alignment with the theme of the World Press Freedom Day (WPFDF) 2026, devoted to Digital Human Rights.

With the advent of the AI revolution, AI Ethics and AI Literacy grounded in a people's-centred approach have become an integral part of the evolving MIL landscape, with a proactive action from UNESCO. At the same time, Tech Diplomacy has emerged as a field of high priority both to UNESCO and UN to ensure that emerging digital technologies align with human rights, ethics and SDGs, building digital bridges between nations and promoting inclusive, ethical AI and transparency of AI and digital platforms' governance.

As 2026 marks the 15<sup>th</sup> Anniversary of the UNESCO-UNITWIN University Network on Media and Information Literacy and Intercultural Dialogue (UNESCO-MILID) and in Celebration of World Press Freedom Day (WPFDF) 2026, this First Edition of the International Spring Academy on Media and Information Literacy Diplomacy (ISA-MILID) aims to highlight the MIL perspective in educational innovation, policy-making, development agendas and international cooperation by bridging the gap between MIL and Diplomacy, while celebrating WPFDF 2026 and commemorating 15 years in the life of UNESCO-MILID, of which Moulay Ismail University is a Founding Member.

#### **Rationale of ISA-MILID 2026**

The First Edition of the International Spring Academy on Media and Information Literacy Diplomacy (ISA-MILID) is organised by the Research Group on Intercultural Communication, Dialogue and Conflict Resolution, the Research Laboratory LaRCIGALS (Research Laboratory

on Communication, Interculturality, Gender, Arts, Language and Society), the Faculty of Arts and Humanities and Moulay Ismail University of Meknes in Morocco, in cooperation with the UNESCO-UNITWIN University Network on Media and Information Literacy and Intercultural Dialogue (UNESCO-MILID) and MEDEA, Mediterranean Europe and Africa.

This global event, the first of its kind, will gather Eminent Speakers from around the world, and will feature Lectures, Panel Discussions as well as Training Workshops for Doctoral Students, aiming to bring new insights into a transdisciplinary and multistakeholder approach of a Human Rights-based MIL for All and to build partnerships to advance Media, Information and Technology Literacy as a fundamental human right to be accessible and empowering to all.

### **Main Themes of ISA-MILID 2026**

The focus of Media and Information Literacy Diplomacy this year is on linguistic, cultural and media rights to exist, to preserve diversity and to prosper in the digital age as fundamental human rights, including the right of universal access to MIL education in one's own language, adapted to one's own culture and needs, the preservation of indigenous languages and cultures, promotion of MIL Cities as a catalyst of MIL for All and by All, and the transversal themes of gender equality, freedom of expression, and information integrity.

Special attention will be given to both opportunities and challenges of AI in the cross-disciplinary fields of language, communication, culture, media and information, taking into consideration the threats of disinformation and hate speech and the increasing threats to freedom of the press and safety of journalists, threats to academic freedom and freedom of expression.
